CMHA Hamilton provides a wide array of services to adults living with mental illness. As the coordinator of Community Enrichment Services, I act as the team lead for the program which provides intensive case management. Students would have a small caseload of individuals and work collaboratively towards their mental health recovery. Students will engage in direct clinical practice, integrate theory and practice, assessment, planning and will have the opportunity to work in program development. Students will also be able to connect with other programs such as court support, supportive housing, peer support and health promotion to understand the wide range of services we offer. By the end of the placement students should have the foundation for advanced generalist practice.
