Incorporated in 1988, Community Family Services of Ontario (CFSO) is a non-profit, charitable, accredited, professional family and settlement services agency with a focus on East Asian Ontarians. Funded by the federal, provincial, and municipal governments, United Way GTA, and the community, CFSO has a goal to improve the overall psychosocial well-being of Chinese-Ontarians and to empower them to contribute to a safe community with harmonious families. CFSO's team of psychotherapists, social workers, certified gambling counsellors, family therapists, speech-language pathologist, and settlement workers provide settlement and counselling services to over 5,000 individuals per year.

There are two placement opportunities:

- 1. **Clinical Counselling-** Our service and learning opportunities available to practicum students (clinical counselling focus) include:
- Individual, dyadic and group supervision (OCSWSSW/CRPO/AAMFT/CAMFT)
- Provide short to mid-term psychotherapy (8-12 sessions) and single session counselling services for individuals, couples, and families.
- To be exposed to cases such as mental health, family and couple concerns, problem gambling, and violence against women and to participate in processes including clinical, seminar facilitation, and outreach.
- Master the clinical and interpersonal skills to work with newcomers and Chinese immigrants in Canada. Learn about the social services system in Toronto.
- Opportunity to facilitate group programs.
- Professional development and in house clinical training opportunities.
- 2. Settlement Service Focus- Our service and learning opportunities available to practicum students (settlement service focus) include:
- Provide administrative and service support to Settlement Program which provides information, orientation, referral and needs assessment, supportive settlement counselling, crisis intervention and other related services to newcomers. Develop, implement, document, and follow up on service plans.
- Participate actively in external community partnership development, networks and project development.

- Design and implement career counselling and language programs for newcomers. Support the youth service and national policy pathways mandates of the agency (if applicable).
- Plan and organize settlement activities and workshops in sync with funder and agency requirements.
- Prepare accurate and complete case notes and records, correspondences, reports; develop educational and promotional materials
- Complete telephone or walk-in intake interview and respond to enquiries, to determine the nature and course of the service, and to triage clients for quick access therapy or ongoing counselling programs.
