



# Michael Garron Hospital, Thorncliffe Park Youth Wellness Hub of Ontario 45 Overlea Blvd, Toronto, Ontario

Year 2 Practicum September 2024 – April 2025

## **Practicum Description**

The practicum site is within the East York Town Center in the Thorncliffe Park Youth Wellness hub of Ontario. This hub has many different services in addition to the mental health programs that the student will work within. The practicum will mainly consist of providing short-term individual therapy (up to 10 session) for youth age 12 to 25. There will also be an opportunity to co-facilitate groups and complete program development. The student will also have an opportunity to shadow the social workers and psychiatrist who work in the Transitional Youth Program at Michael Garron hospital.

The hub is open 11am to 7pm. Due to this some evenings may be required, especially when running groups. We will not expect the student to be at the hub past 7 or past 5 on Fridays.

This is a community-based practicum and is not at a hospital. The student will be connected to Michael Garron Hospital, as that is where I am employed.

#### **Practicum Requirements.**

- Immunizations per PHA Guidelines
- N95 Respirator/Mask Fitting
- Covid Vaccinations
- Influenza Vaccination (Flu shot)
- Police Reference/Vulnerable Sector Check
- Comfort working with the population being served
- Comprehensive report writing and documentation
- Evening attendance
- Language (specify in field below)
- Other requirements: Competency in other languages is not needed and we support youth who are primary BIPOC and speak multiple different languages at home. There are at times when clients who do not speak English require services. Examples of languages are: Urdu, Pashto, Hindi, Punjabi, Tamil, etc.
